**TITLE**: Streetcar Feasibility Study along Sistrunk Boulevard

### **Recommendation**

It is recommended that the CRA Board expend up to \$300,000, payable to the City of Fort Lauderdale, to complete a streetcar feasibility study along Sistrunk Boulevard.

### **Background**

At the October 21, 2014, CRA Board Meeting, the Board requested that a feasibility study be completed to extend the Wave Streetcar along Sistrunk Boulevard from the existing project alignment westward to the City limits. Per the agreement between the City of Fort Lauderdale and Broward Metropolitan Planning Organization (MPO) for Transportation Planning Services approved at the September 3, 2014 Commission meeting, City staff will negotiate a task order to complete the feasibility study. The study is anticipated to cost less than \$300,000 and will be finalized within 6 weeks of a notice to proceed. A presentation will then be made on the findings.

#### Resource Impact

The feasibility study will be funded by Community Redevelopment Agency. Contingent upon the approval of the related Budget Amendment CAM 14-1218, there will be a fiscal impact to the City of \$300,000.00.
