

RESOLUTION NO. 23-17

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, DENYING THE APPLICATION BY EDWARD JOHN KIRWIN, III, FOR A WAIVER OF LIMITATIONS FOR THE INSTALLATION OF FOUR (4) TRIPLE-PILE CLUSTERS EXTENDING 60'+/- AND THREE (3) SINGLE MOORING PILES EXTENDING 38'+/- INTO THE NEW RIVER PROPERTY LINE PURSUANT TO SECTIONS 47-19(e) OF THE CITY OF FORT LAUDERDALE UNIFIED LAND DEVELOPMENT REGULATIONS ("ULDR"), FOR PROPERTY LOCATED AT 777 SW 6TH STREET, FORT LAUDERDALE, FLORIDA.

WHEREAS, Section 47-19.3(e) of the City of Fort Lauderdale, Florida Unified Land Development Regulations (hereinafter "ULDR") provides that the City Commission may waive the limitations of Sections 47-19.3(c), and/or 47-19.3(d) under extraordinary circumstances; and

WHEREAS, Edward John Kirwin, III (hereinafter "Applicant") owns the Property located at 777 SW 6th STREET, Fort Lauderdale, Florida, 33315, Property ID# 5042 10 40 0030 (hereinafter "Property"); and

WHEREAS, Applicant submitted an application for a Waiver of Limitations to allow the installation of four (4) triple-pile clusters extending a 60'+/- and three (3) single mooring piles extending 38'+/- feet from the Applicant's Property line into the New River (hereinafter "Application");


NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. That each WHEREAS clause set forth above is true and correct and incorporated herein by this reference.

SECTION 2. That the City Commission of the City of Fort Lauderdale, Florida, finds that the Application for a Waiver of Limitations to install four (4) triple-pile clusters extending a 60'+/- and three (3) single mooring piles extending 38'+/- feet from the Applicant's Property line into the New River is hereby denied.


SECTION 3. That this Resolution shall be in full force and effect upon final adoption.


