TITLE: Motion Approving Aggregate Increase to the Agreements for Pumping

Services - Green Team Plumbing, LLC d/b/a Greenteam Service Corporation, A & A Drainage & Vac Services, Inc., EnviroWaste Services Group, Inc., and All Liquid Environmental Services LLC d/b/a Johnson Environmental Services - \$200,000 - (Commission Districts 1, 2, 3 and 4)

Recommendation

Staff recommends the City Commission approve an aggregate increase of \$200,000, from \$400,000 to \$600,000 to the initial two-year term and \$100,000 per year for two one-year renewal options to the Pumping Service Agreements with Green Team Plumbing, LLC d/b/a Greenteam Service Corporation, A & A Drainage & Vac Services, Inc., EnviroWaste Services Group, Inc., and All Liquid Environmental Services LLC d/b/a Johnson Environmental Services, increasing the potential total contract aggregate amount from \$800,000 to \$1,200,000, contingent upon appropriation of funds.

Background

On September 6, 2022, the City Commission awarded four contracts for pumping services. The agreements were for the aggregate amount of \$400,000 for the initial two-year term and authorized the city manager to approve two (2) one-year renewal options in the estimated amount of \$200,000, for a potential total contract amount of \$800,000, contingent upon appropriation of funds (CAM #22-0575).

Agreements were executed with the following entities:

- Green Team Plumbing, LLC d/b/a Greenteam Service Corporation
- A & A Drainage & Vac. Services, Inc.
- EnviroWaste Services Group, Inc.
- All Liquid Environmental Services, LLC, d/b/a Johnson Environmental Services

The Public Works Utilities Division staff maintain 476 miles of sewer gravity mains and 186 wastewater pumping stations throughout the City. Staff is equipped to handle the workload under normal conditions utilizing City vactor trucks and assets. However, for

extreme conditions such as severe rain events, extensive power outages, and hurricanes, it is necessary to have additional resources to maintain infrastructure resilience and provide a high level of service.

As of today, staff has spent most of the funds in the annual agreements for pumping services due to multiple repairs, emergencies, and failures. Staff is requesting a combined increase of \$400,000, \$200,000 to the initial term and \$100,000 for each renewal term of the agreements, to provide the required emergency response and continued level of service, especially during the hurricane season starting June 01, 2024.

Resource Impact

There will be a current fiscal year impact to the City in the amount of \$200,000 for this increase. Funds for this increase are available in the FY 2024 Operating Budget in the account listed below. Future years' expenditures are contingent upon the approval and appropriation of the annual budgets.
