**TITLE:** Motion approving Grant Agreement Broward County, Land Stewardship Program, Partners in Preservation Grant, Snyder Park Quad 1B in the amount of \$40,000. No City Match Required.

**Recommendation**

It is recommended that the City Commission approve a motion authorizing the proper city officials to execute a Grant Agreement with Broward County, Land Stewardship Program, Partners in Preservation Grant, Snyder Park Quad 1B in the amount of \$40,000.

**Background**

On March 22, 2013, the Parks and Recreation Department submitted a Partners in Preservation grant application to Broward County. Funds will be used to eradicate invasive non-native vegetation and replanting with native vegetation. No city match is required.

Grant funds are available for sites that were acquired through the 2000 Safe Parks and Land Preservation Bond Program; supplemental grant funds have been made available for the ecological restoration of publicly owned natural lands and sustainable development of passive recreation parks.

In May of 2013, staff received notification from Broward County acknowledging approval of the grant in the amount of \$40,000. The Grant period will be twelve (12) months from the date of execution.

**Resource Impact**

There is a positive impact to the City in the amount of \$40,000. Funds are being appropriated through companion item #13-0815.
