**Recommendation**

It is recommended that the City Commission approve two Task Orders with Keith and Schnars, PA for small water main improvement design services in the total amount of \$175,350 for the Victoria Park 'A' North project (\$108,560) and for the Lake Ridge Sunrise Boulevard project (\$66,790).

**Background**

The Victoria Park "A" North project involves the replacement of 24,000 linear feet of existing undersized water mains within residential neighborhoods, north of Northeast 6<sup>th</sup> Street between Northeast 7<sup>th</sup> Avenue and Northeast 20<sup>th</sup> Avenue. The project was designed and permitted by City staff with a small portion constructed by City crews on Northeast 16<sup>th</sup> Avenue and Northeast 19<sup>th</sup> Avenue. The City is transferring obligations as Engineer of Record (EOR) to Keith and Schnars, P.A. and completing the remainder of improvements through a public bid process.

The Lake Ridge Sunrise Boulevard project involves the replacement of 4,000 linear feet of existing undersized water mains on Sunrise Boulevard between Flagler Drive and Federal Highway. The project was designed by City staff, but never permitted. The City is transferring obligations as Engineer of Record (EOR) to Keith and Schnars, P.A. and completing the improvements through a public bid process.

These task orders are being entered into pursuant to the continuing contract for civil engineering consultant services (Contract 626-10881) with Keith and Schnars, P.A., in accordance with the terms of the amended master agreement dated November 6, 2012 (CAR #12-2299) and renewed on October 21, 2014 (CAM #14-1066).

### **Resource Impact**

There will be a fiscal impact to the City in the amount of \$175,350 for both task orders and \$17,535 for in house project management fees, for a total of \$192,885.
