TITLE: Motion Approving An Allocation of Community Development Block Grant

(CDBG) for Broward County Habitat Community Housing Development Corporation with Joinder and Consent by Habitat for Humanity Broward, Inc.

Not to Exceed \$482,000 - (Commission District 3)

Recommendation

Staff recommends the City Commission, by motion, approve an allocation of CDBG funds not to exceed Four Hundred Eighty-Two Thousand \$482,000, to help offset unanticipated costs that have occurred in the preparation to construct Habitat BBI Village project, and authorize the City Manager to execute agreements and associated documents relating to this action.

Background

On December 19, 2023, via CAM #23-1215, the City Commission adopted a resolution approving an Affordable Housing Development Agreement and Assumption of Liability and Hold Harmless Agreement between the City of Fort Lauderdale and Habitat for Humanity Broward, Inc for the development of twenty (20) townhouse units for affordable homeownership.

On February 20, 2024, via CAM #24-0132 City Commission approved a Funding Agreement with the Broward County Habitat Community Housing Development Corporation ("CHDO") with joinder and consent by Habitat for Humanity Broward, Inc, in the amount of \$1,520,872.63 as gap financing for the development and construction of twenty (20) affordable townhomes for homeownership. This approval will result in a cumulative award of \$2,002,872.63 for this project.

After the execution of the Funding Agreement, Habitat proceeded with the process of obtaining the various permits needed to begin construction including a Broward environmental review and a Surface Water Management (SWM) permit. The SWM permit presented unexpected challenges. On February 21, 2024, the County issued comments requiring the retention of water from a 100-year, 3-day storm on site. This requirement necessitated a structural assessment of an existing masonry wall, which was ultimately deemed insufficient. As a result, the project team had to revise the site drawings to include

the reconstruction of the wall. The project will incur additional costs for the structural assessment of the existing wall, revision of site plans to include a new wall, demolition and removal of existing masonry wall and construction of the new wall to meet today's Surface Water Management standards.

Resource Impact

There will be a fiscal impact in the amount of \$482,000. There is no General Fund impact, the project will be grant funded.
