AUTHORIZING EXECUTION AND DELIVERY TO THE STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION AN EASEMENT FOR RIGHT OF WAY OR PUBLIC ROAD PURPOSES AND UTILITIES, A COPY OF SUCH EASEMENT DEED BEING HERETO: ATTACHED REPEALING ANY AND RESOLUTIONS IN CONFLICT HEREWITH; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the State of Florida Department of Transportation proposes to construct or improve State Road No. <u>C.S.X. RR.R</u>, Item/Segment No. <u>406191</u>, Section <u>86070-2453</u>, in <u>Broward</u> County, Florida: and

WHEREAS, it is necessary that an easement across certain lands now owned by the City of Fort Lauderdale, Florida, be acquired by the State of Florida Department of Transportation: and

WHEREAS, said use is in the best interest of the City; and

WHEREAS, the State of Florida Department of Transportation has made application to said City to execute and deliver to the State of Florida Department of Transportation for <u>right of way or public road purposes and utilities, including the right of access, ingress, egress, and such other rights that are necessary and incidental to said construction and maintenance thereof, and said request having been duly considered;</u>

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. That the application of the State of Florida Department of Transportation for a perpetual easement is for transportation purposes which are in the public or community interest and for the public welfare.

SECTION 2. That the proper City officials are hereby authorized to execute and deliver a Permanent Easement Deed to the State of Florida Department of Transportations for right of way or public road purposes and utilities, including the right of access, ingress, egress, and such other\_rights that are necessary and incidental to the said construction and maintenance thereof, a copy of such Permanent Easement Deed being attached hereto as Exhibit "A"

<u>SECTION 3</u>. That the Office of the City Attorney shall review and approve as to form all documents prior to their execution by City officials.

SECTION 4. That this Resolution shall be in full force and effect upon final passage.




