INTRODUCTION

NEW DEVELOPMENT

This proposal is to utilize the existing vacant site for a development that will provide an arts and cultural event space to the City of Ft. Lauderdale. The center will be a new six thousand square foot, two story building with parking on the ground level. Access for the site will be in the northwest corner of the site. The parking for the site will be provided underneath the structure to the north side of the site. The new building will also host 2 additional organizations with similar missions and target populations that will occupy the available space in the development.

PROPOSED USE

The proposed project is the construction and operation of the Marie A Wells (MAW) Arts and Education Center Inc. further referred to as "the Center"

IMPACT

Economic Impact

According to a 2012 study performed by Americans for the Arts; arts organizations are responsible businesses, employers, and consumers. Spending by nonprofit arts and culture organizations, which is just a fraction of the total arts and entertainment industry, was an estimated \$61.1 billion in 2010, and leveraged an additional \$74.1 billion in event-related spending by arts audiences. This \$135.2 billion in economic activity supported 4.1 million FTE jobs and generated \$22.3 billion in total government revenue. We wholeheartedly believe that our Arts and Culture Center will become a cultural attraction and deliver much needed revenue and employment opportunities to the Sistrunk area.

Cultural Impact

A <u>Brookings Institute</u> 2019 study, found that a substantial increase in arts educational experiences has remarkable impacts on students' academic, social, and emotional outcomes. Relative to students assigned to the control group, treatment school students experienced a 3.6 percentage point reduction in disciplinary

infractions, an improvement of 13 percent of a standard deviation in standardized writing scores, and an increase of 8 percent of a standard deviation in their compassion for others. In terms of our measure of compassion for others, students who received more arts education experiences are more interested in how other people feel and more likely to want to help people who are treated badly. We are certain that the high-quality programs we plan to deliver at our center will enrich the lives of the children and adults in our service area, the City of Ft. Lauderdale.

Disaster Response and Recovery

We believe that long after the current pandemic and any subsequent weather-related emergencies that our community may be impacted by, this center will be a strong community partner to assist residents in the recovery process. It has been proven in municipalities impacted by trauma, that exposure to the arts helps in the healing process. The arts are a vital component of the revitalization of disaster-affected communities. Additionally, the arts illuminate the human condition, bring people together, and provide a crucial vehicle for healing. Disaster recovery includes addressing the emotional and spiritual healing of the community in addition to material necessities such as food and shelter; research shows that arts-based therapies in the aftermath of disasters reduce rates of distress, depression, and anxiety and increase hope, feelings of well-being and safety, and overall confidence.

THE PROJECT

The MAW Arts and Education Center Inc. "The Center" will be dedicated to promoting arts and culture in the City of Fort Lauderdale with a specific focus in the Sistrunk Corridor and Northwest Gardens. Our purpose is to make this center a setting where opportunities for telling stories musically, in words or motions, which can offer individuals possibilities beyond their current parameters.

The Center will play a dual role in community development through the promotion of arts and culture. As an arts venue, the Center will host film festivals, art festivals, comedy shows and talent showcases. As an arts and theater education program, the Center will provide an opportunity for the children and adults of the City of Ft. Lauderdale to receive the benefit that theater activities can provide. We believe residents may experience many benefits that include but are not limited to:

Foster self-worth based on positive accomplishment and development of creativity.

Create sensitivity to others through teamwork.

We have assembled a non-paralleled group of professionals to bring this project to fruition. Please find attached the resumes for team members who will serve as project leadership.

CONSTRUCTION MATERIALS AND METHODOLOGY

Construction of the new building will be disaster resilient, utilizing materials that include reinforced concrete block and Miami-Dade approved wind and impact resistant windows and doors. We are proposing to install a tile roof also utilizing methods and materials designed to resist wind and uplift that meet current Miami-Dade product approval. Sustainable building methods focused on creating an energy efficient structure will be incorporated in the project design. All construction drawings, specifications and methods utilized will meet local building codes.

Our proposed project is in alignment with existing area zoning and is consistent with the nature of the surrounding neighborhood, which is currently a mix of commercial development and residential properties. The traffic patterns in the neighborhood are already well established and will not be affected by the new development. As we work with our design professional team and City representatives, we understand that a building can be made more resilient by building beyond the building code, therefore we will seek to incorporate methods to increase the longevity of the structure as well as create a showplace that our community can take pride in.

PARKING

The open parking garage underneath the structure will be naturally ventilated with partially and completely open walls to allow air to move in and out to avoid buildup of gases. The ADA compliant parking spaces will be adjacent to the exterior elevator to permit easy access for entry at the reception area. A stairway for emergency egress will be accessible near the garage elevator

SECURITY

The building will incorporate security features including cameras, security alarms and lockable elevators to deter crime and increase the comfort level of patrons and staff.

BUILDING AMENITIES

Exterior esthetics will include, an exterior elevator to travel from the parking area to the interior, a stairway for emergency access, decorative wood finished metal African motifs, decorative stamped concrete, American Disability Act (ADA) compliant pavers and theatre style canopies at the main entrance to the east and Actors patio area to the west.

Interior amenities will include a reception area that will also serve as a holding area for patrons MAW Proposal Page 4

attending film festivals, musicals and other performing arts events held at the center. Also located on this floor are the auditorium with stage and storage area for props, performers dressing rooms, hand sanitizing stations, ADA compliant restrooms to accommodate up to three males and three females simultaneously.

The upper level will boast classrooms, a conference area that may be scheduled for community meetings and two offices available for lease, as well as ADA compliant restrooms to accommodate up to two males and two females simultaneously. The upper level may be accessed by a separate elevator that will hold enough persons as required by local codes or the stairways.

SIGNAGE

Building signage will be attractively placed visible to the Sistrunk Corridor in preferred areas, however signage will be approved under separate submittals from the developer. A marquee type sign to highlight hosted events is under consideration, but the location and design has not yet been determined. This will also be forwarded for approval under the submittal process.

LANDSCAPING

Xeroscaping with low maintenance and lowered water consumption features will be installed at the site. This more environmentally sensitive approach will also utilize only Florida One plantings. The process will follow all state and local guidelines as outlined in the City of Ft. Lauderdale ordinances.

PLAN OF OPERATION

As mentioned, the building is being developed as an arts and cultural center. Our proposed project will result in an asset to the community where life and social values can be imparted through the arts. As ensembles of artist help students learn to appreciate the arts and to develop respect, tolerance and patience for all ages, genders, social and ethnic backgrounds, they will each work toward a common goal; individual and collective growth.

As an arts venue, the Center will host film festivals, art festivals and other cultural events. Through hosting events such as annual film festivals, there is the opportunity for increased visibility and economic increase to the area as artist, directors, executives, and videographers, showcase talents and present films. Art Festivals will encompass a wide range of art forms including music, dance film, fine art, literature, poetry, and visual arts. Comedy shows and other interactive talent showcases which will feature a local talent.

The arts and cultural education program promise workshops for adults and afterschool and summer sessions for students that include but are not limited to:

community.

The mission and esthetics are planned to be complimentary to the African American Research Library,

located to the west at Sistrunk Boulevard and 27th as well as the Urban League of Broward County on

once an industrial warehouse district, now teaming with art galleries and studios and the FATVillage
