TITLE: Motion to award the purchase of VisionLive on-premise subscription
services – \$27,951 (two-year cost)

Recommendation

It is recommended that the City Commission award a two-year maintenance support agreement for VisionLive on-premise subscription services to Vision Internet Providers, Inc., utilizing the General Services Administration (GSA) Contract GS-07F-0509W, in the total two-year amount of \$27,951, in substantially the form attached.

Background

On December 16, 2008, the City Commission approved the award of an agreement (solicited via Request for Proposal 185-9957) with Vision Internet Providers, Inc. to redesign the Police Department (FLPD) website at a cost of \$58,995. The redesign provided Content Management Software (CMS), which allows the ability to modify content on any page in the website through simple and easy to use administration screens.

In June, 2012, the Information Technology Services Department purchased custom web design services to redesign the City's website, including an upgrade to the FLPD web site and a special sustainability portal for the Public Works Department for a total cost of \$38,763. This purchase was made utilizing the GSA contract held by Vision Internet Providers, Inc. (GS-07F-0509W).

Currently, a new version of this software has been released as part of the Vision Internet Providers, Inc. maintenance support agreement. The new CMS enhances management features for the City web site, has tools to interact with social networking sites and has expanded accessibility features. The maintenance subscription services agreement is \$12,418 for the first year plus a one-time \$3,112 upgrade/task order change fee (total year one = \$15,530). The annual cost for year two will not exceed \$12,421. The total two-year cost for this service agreement will not exceed \$27,951.

Resource Impact

There will be a fiscal impact to the City in the amount of \$15,530. Future expenditures are contingent upon approval and appropriation of the annual budget.
