TITLE: Resolution Approving and Ratifying Second Addendum to Agreement with Musco Sports Lighting, LLC for the Purchase, Delivery and Installation of Additional Equipment and Amenities for Various Parks and Playgrounds - \$165,000 - (**Commission District 1**)

Recommendation

Staff recommends the City Commission adopt a resolution approving and ratifying an executed second addendum to a contract entered into by and between the City of Fort Lauderdale and Musco Sports Lighting, LLC, in substantially the form attached, for the purchase, delivery and installation of additional equipment and amenities at George English Park for an estimated amount of \$165,000 via the Clay County Contract 18/19. Commission approval is required given this award exceeds the \$100,000 threshold.

Background

The athletic field lighting in many of the City parks is outdated and inefficient. In many cases, manufacturers are no longer making replacement fixtures, which result in lower lighting levels and dangerous playing conditions.

On June 15, 2021, the City Commission approved a project to upgrade athletic field lighting at the following eight (8) different parks) for a total the amount of \$4,124,495.00: Bayview, Croissant, Floranada, Florence C. Hardy, Holiday, Mills Pond, Osswald, and Sunset (CAM #21-0554).

On April 5, 2022, the City Commission approved the first addendum to an agreement with Musco Sports Lighting, LLC, in the amount of \$709,000.00, for the purchase, delivery and installation of sports lighting equipment at two (2) additional park locations - Joseph C. Carter and Holiday Park (Pickleball & Roller Hockey) (CAM #22-0153).

Subsequently, staff identified that field lighting improvements are needed at George English Park. Upgrading the existing light fixtures to LED will result in a 40% to 60% decrease in electricity usage, increased lighting levels and safety, as well as reduced maintenance costs. The described upgrades are included in the Parks Bond program as funded improvements. The City received a quote from Musco Sports Lighting, LLC, for

an estimated total amount of \$165,000. via the Clay County Contract 18/19-2, for the purchase, delivery and installation of the new light fixtures and associated control systems.

Pursuant to Section 2-181(f)(5)(b), Code of Ordinances of the City of Fort Lauderdale, Florida, the City is authorized to piggyback a contract entered into by another governmental or public entity and a provider of supplies or services required by the City, if the Chief Procurement Officer determines that it is practicable and advantageous for the City to employ this method of procurement.

The Chief Procurement Officer has determined that it would be practicable and advantageous for the City to piggyback the Clay County Contract No. 18/19-2 with Musco Sports Lighting, LLC, for the purchase, delivery and installation of additional equipment and amenities at George English Park for an estimated amount of \$165,000, and on August 18, 2022, City Manager approved a second addendum to the piggyback contract between the City of Fort Lauderdale and Musco Sports Lighting, LLC, in an amount of \$165,000 via the Clay County Contract 18/19.
