TITLE: Motion Authorizing Professional Services for Large Water Main
Improvements Project at Port Condo (SE 17th Street) - Keith and Schnars,
P.A. - \$48,050

Recommendation

It is recommended that the City Commission approve Task Order No. 7 (Exhibit 1) with Keith and Schnars, P.A. for water main improvement design services on Southeast 17th Street (Exhibit 2) in the amount of \$48,050.

Background

This project involves the installation of 1,800 linear feet of large water main to enhance existing service to the commercial properties on Southeast 17th Street (Marriott Drive). The project design needs to be updated to allow for coordination with private development improvements. Additionally, the plans need to be permitted with the Florida Department of Transportation (FDOT) and the Broward County Department of Health (BCDOH).

This Task Order is being entered into pursuant to the City's continuing contract for civil engineering consultant services (Contract 626-10881) with Keith and Schnars, P.A., in accordance with the terms of the amended master agreement dated November 6, 2012 (CAR #12-2299) and renewed on October 21, 2014 (CAM #14-1066).

Resource Impact

There will be a fiscal impact to the City in the amount of \$48,050 for the Task Order and \$4,805 for in house project management fees, for a total of \$52,855.
