Re: Housing Authority of the City of Fort Lauderdale (HACFL) Community Bus Service Funding

Dear Ms. Henry:

On August 21, 2012, the Fort Lauderdale City Commission held a public hearing regarding the discontinuance of the HACFL Community Bus Service funded through an agreement between Broward County and City of Fort Lauderdale for Community Bus Service, which the City proposes not to renew, effective October 1, 2012. The Commission deferred taking action for non-renewal of the City-County Community Bus Interlocal Agreement until its September 5, 2012 meeting. The purpose of this letter is to request that the County reconsider increasing funding for the HACFL Community Bus Blue and Red routes for continued service, given the high ridership and need for these routes.

Currently, the County provides \$15 per revenue service hour for both routes that run Monday through Friday from 7:00am to 5:00pm. The current annual funding level is approximately \$75,465. This service is in jeopardy due to the Housing Authority's non-renewal of their contract with the City due to an approximate \$56,312 shortfall for operations including fuel, labor and maintenance.

Attached, please find a copy of the HACFL timetable and map. As you can see, both routes extend outside of the City limits of Fort Lauderdale into Lauderhill (Lauderhill Mall) and Plantation. This constitutes approximately 32% of the route mileage that operate outside of the City's jurisdiction. In the HACFL's Mobility Management Plan study released in August 2011, it was discovered that only 7.7% of its riders were actually residents of HACFL properties. Therefore, we believe that since these routes serve a regional population, there should be a partnership with the county and the other jurisdictions to provide this much needed and popular service.

The Blue and Red routes have some of the highest ridership numbers in the county with 15.4 and 20.5 Passengers Per Hour (PPH), respectively, and serving an average of 6,400+ riders monthly. These routes are vital to the community in that they provide a free service to the area's low-income population, as well as the elderly. While there may be other routes that technically duplicate these routes, they may not provide the ease and convenience riders have enjoyed with the Blue and Red routes. The elimination of these routes will create an immediate negative impact in the community. Without additional funding from the County, this service will discontinue on October 1, 2012.

There is a possibility of the Downtown Fort Lauderdale Transportation Management Association (TMA) agreeing to operate these routes in the future; however, the TMA Board has made it very clear that they will do this only if the routes are 100% funded by other parties. When the County reduced its Community Bus funding contribution from \$20 per hour to the current \$15 per hour in the 2009-10 fiscal year, no provisions were made to increase the maximum percentage (50%) of the full adult fixed-route fare that a municipality charges to offset the additional costs. At that same time, the County increased the minimum PPH standard from 5.0 to 7.1 PPH. The TMA struggles with the low \$15 per hour funding provided by the County for their routes and cannot make the financial commitment to extend the services they currently provide.

There is a specific issue for Gateway Terrace, an elderly community, which has been without bus service since the BCT Route #55 in that area was discontinued in November 2008 due to low ridership. It has been a continuing quest by the community to regain bus service. The TMA and the City are not averse to providing service to Gateway Terrace if the County provides 100% funding for the service. We feel this request is not without precedent, as in November 2010 when Broward County cut BCT Route #57 in Tamarac, it provided 100% funding to Tamarac's Red Bus Route to help compensate for the loss of service.

In summary, Renewal of the city-county interlocal agreement is contingent upon the county agreeing to the following:

- Additional \$56,312 for continual service of the HACFL Blue and Red routes for the 2012-13 fiscal year
- Amend the interlocal agreements to increase the Community Bus fare ceiling higher than 50% of the BCT full adult fixed route fare
- Provide 100% funding to allow the TMA to provide service to Gateway Terrace

Thank you in advance for your expedited consideration of these requests before the next City Commission meeting, September 5, 2012.
