### Recommendation

It is recommended that the City Commission adopt a resolution approving the renaming of 15<sup>th</sup> Street Boat Ramp to Cox's Landing 15<sup>th</sup> Street Boat Ramp to honor former City of Fort Lauderdale Mayor Robert Cox.

### **Background**

At the Marine Advisory Board meeting held on September 5, 2013, a motion was passed by Vice Chair Harrison, seconded by Mr. Herhold, through the proper channels, that the Board ask for the support of naming the 15<sup>th</sup> Street Boat Ramp to Cox's Landing 15<sup>th</sup> Street Boat Ramp (Exhibit 1).

In compliance with the Guidelines for Naming Parks, Recreation Areas and Facilities (Exhibit 2), Parks and Recreation staff notified the surrounding homeowners associations of the suggested re-naming (Exhibit 3). In return, The Parks and Recreation Director received a letter from Harbordale Civic Association in support of the re-naming (Exhibit 4). In addition, two Public Advisory Notices were placed at the 15<sup>th</sup> Street Boat Ramp to notice that the proposed re-naming would be placed on the agenda at the October 23, 2013 Parks, Recreation and Beaches Board Meeting. The item was placed on the October 23, 2013 Parks, Recreation, and Beaches Board Agenda for discussion. After reviewing the item, a motion was made by Richard Zaden, seconded by Karen Polivka, to support the renaming of 15<sup>th</sup> Street Boat Ramp to "Cox's Landing 15<sup>th</sup> Street Boat Ramp".(Exhibit 5).

Parks and Recreation Staff recommends approval of renaming the 15<sup>th</sup> Street Boat Ramp to Cox's Landing 15<sup>th</sup> Street Boat Ramp, to honor former City of Fort Lauderdale Mayor Robert Cox.
