Recommendation

Staff recommends the City Commission authorize the consent to the assignment and assumption of the lease agreement by 2611 East Oakland Park, LLC to North Broward Hospital District d/b/a Broward Health for air rights located at 2611 E Oakland Park Boulevard, Fort Lauderdale, Florida 33301 (Exhibit 1).

Background

Adams Building Associates, a Florida general partnership, and the City of Fort Lauderdale ("City") entered into a lease agreement on September 30, 1986 (Exhibit 2). Adams assigned this lease to Coolidge Enterprises, Inc., a Florida corporation, on May 23, 1996, and subsequently, the lease was assigned to Michigan Oakland Park Corp., a Michigan corporation, on May 1, 1998. The lease was then assigned by Caproc Oakland Park, LLC, as successor by merger to Michigan Oakland Park Corp, to BE ML FLL LLC, a Florida limited liability company, on December 17, 2012. Following this, the lease was assigned by BE ML FLL LLC to 2601 M L Fund, LLC, another Florida limited liability company, on April 8, 2015. Finally, the lease was assigned by 2601 M L Fund, LLC to 2611 East Oakland Park LLC, a Florida limited liability company, on November 21, 2017 (Exhibit 3).

The original lease term runs from October 1, 1988, to September 30, 2028, with an option for a nine-year renewal. The initial annual rent was \$285. The current rent is \$732 and is adjusted annually based on the Consumer Price Index.

On April 12, 2024, the City received a request from 2611 East Oakland Park, LLC, to assign the air rights to Broward Health (see Exhibit 4).

**ASSIGNMENT AND ASSUMPTION
OF LEASE AGREEMENT**

THIS ASSIGNMENT AND ASSUMPTION OF LEASE (the "Assignment & Assumption") is made and entered as of September 25th, 2024 by and between 2611 EAST OAKLAND PARK LLC, a Florida Limited Liability Company ("Assignor") to North Broward Hospital District d/b/a Broward Health and/or assigns ("Assignee"), is as follows:

WHEREAS, ADAMS BUILDING ASSOCIATES, a Florida general partnership ("Adams") and the City of Fort Lauderdale ("City") entered into that certain Lease Agreement dated September 30, 1986 and recorded in Official Records Book 16009, Page 656, of the Public Records of Broward County, Florida ("Lease"), which is incorporated herein by reference; and

WHEREAS Adams assigned said Lease to COOLIDGE ENTERPRISES, INC., a Florida corporation by Assignment of Lease dated May 23, 1996 and recorded in Official Records Book 24934, Page 0162, and was further assigned to MICHIGAN OAKLAND PARK CORP., a Michigan corporation by Assignment of Lease dated May 1, 1998; and

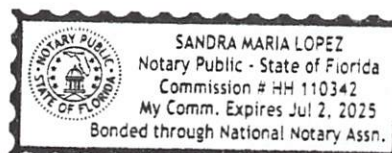
WHEREAS, thereafter the Lease was assigned by CAPROC OAKLAND PARK, LLC, as successor by merger to Michigan Oakland Park Corp, a dissolved Michigan corporation to BE ML FLL LLC, a Florida limited liability company by Assignment of Lease Agreement dated December 17, 2012, said Assignment of Lease Agreement being recorded at Official Record Book 49347, Page 447 of the Public Records of Broward County, Florida; and

WHEREAS, thereafter the Lease was assigned by BE ML FLL LLC, a Florida limited liability company to 2601 M L FUND, LLC, a Florida limited liability company, by Assignment and Assumption of Lease Agreement dated April 8, 2015, said Assignment and Assumption of Lease Agreement being recorded under Instrument #112953273 of the Public Records of Broward County, Florida; and

WHEREAS, thereafter the Lease was assigned by 2601 M L FUND, LLC, a Florida limited liability company, a Florida limited liability company to 2611 EAST OAKLAND PARK LLC, a Florida limited liability company, by Assignment and Assumption of Lease Agreement dated November 21, 2017, said Assignment and Assumption of Lease Agreement being recorded January 1, 2018 under Instrument #114818463 of the Public Records of Broward County, Florida.

WHEREAS, Section 13 of the Lease allows for assignment of this lease by Assignor to Assignee with the consent of the City, and

WHEREAS, the Assignor owns the rights as provided in the Lease and desires to assign, transfer, set over and deliver to Assignee all of Assignor's right, title and interest in and to the Lease by this document;

NOW, THEREFORE, in accordance with the terms of this Consent to Assignment and in consideration of the sum of \$10.00 and other good and valuable consideration, the sufficiency and receipt of which are hereby acknowledged, the parties do hereby covenant and agree as follows:

1. The above recitals are true.
2. The Effective Date of this Assignment & Assumption is the date the Consent to Assignment and Assumption of Lease Agreement is executed by the proper City officials for the City of Fort Lauderdale.
3. As of the Effective Date, Assignor does hereby assign, transfer, set over and deliver to Assignee all of the Assignor's right, title, and interest in and to the Lease.
4. Assignor does hereby represent and warrant that the Lease is in full force and effect and that, to the best of Assignor's knowledge, the Lease is currently in good standing and neither Assignor nor Landlord is in default under the Lease.
5. Assignee hereby accepts this Assignment and expressly agrees to assume all of the Assignor's obligations under the Lease arising after the date of this Assignment.
6. This Assignment shall be binding and inure to the benefit of the parties to this Assignment and their respective heirs, legal representatives, successors and assigns and shall be construed in accordance with Florida law.
