

**SECOND AMENDMENT TO AGREEMENT BETWEEN THE CITY OF FORT  
LAUDERDALE AND TEKSYSTEMS, INC., FOR INFORMATION TECHNOLOGY  
TEMPORARY STAFFING SERVICES**

THIS SECOND AMENDMENT to Agreement between the City of Fort Lauderdale and Teksystems, Inc., for Information Technology Temporary Staffing Services, made and entered into on the \_\_\_\_ day of \_\_\_\_\_, 2015, ("Effective Date"), is by and between the City of Fort Lauderdale, a Florida municipality, ("City"), whose address is 100 North Andrews Avenue, Fort Lauderdale, FL 33301-1016, and Teksystems, Inc., a Maryland corporation authorized to transact business in the State of Florida as Teksystems Management, Inc., ("Contractor"), whose address is 7437 Race Road, Hanover, Maryland, 20176.

WHEREAS, the City and the Contractor entered into an Agreement between the City of Fort Lauderdale and Teksystems, Inc., for Information Technology Temporary Staffing Services, dated October 23, 2014, ("Contract"), which agreement was amended *via* Amendment to Agreement between the City of Fort Lauderdale and Teksystems, Inc., for Information Technology Temporary Staffing Services dated May 5, 2015.

NOW, THEREFORE, the City and the Contractor hereby agree as follows:

Paragraph 1 of the Contract is amended to provide as follows: "The Contractor agrees to provide to the City information technology temporary staffing services as the City may request, at prices set forth in State of Florida Term Contract 973-561-10-1 for an amount not to exceed \$384,500."
