
WHEREAS, pursuant to Resolution No. 13-168, adopted on September 12, 2013, the City Commission of the City of Fort Lauderdale adopted the Final Operating Budget of the City of Fort Lauderdale, Florida for the Fiscal Year beginning October 1, 2013, and ending September 30, 2014,

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. That the Final Operating Budget of the City of Fort Lauderdale for the Fiscal Year beginning October 1, 2013, and ending September 30, 2014, is hereby amended by appropriating funds as set forth in Commission Agenda Memo #14-0480, copy of which is attached hereto and incorporated herein.


SECTION 2. That this Resolution shall be in full force and effect upon final passage.

TITLE: Resolution approving a budget amendment – Broward Center for the
Performing Arts pre-payment for capital improvements - \$300,000

Recommendation

It is recommended that the City Commission adopt a resolution amending the Fiscal Year 2014 Budget.

Background

At the July 10, 2012 City Commission Meeting, (CAM 12-1158), City Commission supported a funding request from the Broward Center for the Performing Arts (PACA) in the amount of \$4,500,000 in annual installments of \$300,000 for the next fifteen (15) years. This investment to restore the center to a “State of the Art” status is part of an overall estimated project cost of \$43,000,000. The comprehensive plan to rehabilitate the center includes restoration of theaters, new technology, and new facilities to enhance their award-winning educational programs and the overall experience of attendees.

In an effort to assist the Broward Center for the Performing Arts with leveraging funds for their initiatives, it is recommended that the City make an additional \$300,000 payment during FY 2014, before May 31, 2014. The Broward Center for the Performing Arts is offering a 2.636% discount to the City for the pre-payment. This discount equates to a savings of \$118,613, reducing the City’s total funding commitment to \$4,381,387 over the 15 years. This pre-payment will be in lieu of the final payment, which is currently scheduled for October 1, 2026.

Staff recommends that the City Commission amend the FY 2014 operating budget by amending the appropriate accounts in the General Fund in the amount of \$300,000 to facilitate the pre-payment to the Broward Center for the Performing Arts.

Resource Impact

There is a fiscal impact to the City in the amount of \$300,000 from the General Fund, Anticipated Year-End Fund Balance.
