Mayor Trantalis recognized Phillip Dunlap, Flagler Village Civic Association (Association) President. Mr. Dunlap acknowledged the importance of services provided by Community Court, remarked on the Association's support for this Agenda item as a temporary location for Community Court and the need for continued staff efforts to identify a permanent, alternate location for Community Court within two (2) years.

Commissioner Glassman commented on the five (5) year lease for the building located at 18 NW 1st Avenue (property) that will continue to house Community Court. He remarked on the option to opt out of the lease after two (2) years to facilitate the relocation of Community Court. Commissioner Glassman emphasized the need for ongoing maintenance of the property and the adjacent area.

Mayor Trantalis confirmed his support of this Agenda item as a temporary solution for Community Court. Mayor Trantalis noted that this area has become the entranceway to the heart of the City and discussed his perspective and options for reenvisioning the area.

Mayor Trantalis requested that City Manager Williams engage with the owner of the property to discuss its purchase for redevelopment to create a positive urban experience. Commissioner Glassman discussed his recollection of previous Commission discussions of this topic. Further comment and discussion ensued regarding the opportunity to purchase the property.

Mayor Trantalis recognized Chris Cooper, Acting Assistant City Manager. Mr. Cooper explained the previous property appraisals. Further comment and discussion ensued.

Vice Mayor Herbst concurred with the need to reenvision this area, said that the appraisals were too high, and expounded on his viewpoint regarding locations for homelessness services. Further comment and discussion ensued regarding the fair market value of the property. Vice Mayor Herbst discussed the history of efforts to address the needs of individuals experiencing homelessness, related court decisions, and his perspective regarding the difficulty of relocating Community Court. Vice Mayor Herbst requested that staff begin efforts to determine an alternate location.

Mayor Trantalis remarked on opportunities associated with locating homeless services near the Homeless Assistance Center, reiterated the need to move towards purchasing the property, or pursuing eminent domain proceedings. Further comment and discussion ensued.

Commissioner Sorensen noted his efforts and discussions with homelessness service providers regarding determining a new location for Community Court. Further comment and discussion ensued.

Commissioner Beasley-Pittman discussed her work with the Broward County Continuum of Care to end homelessness and requested Mr. Cooper meet with her for an in-depth, detailed review of staff efforts. Further comment and discussion ensued.

Commissioner Glassman made a motion to approve this Agenda item and was seconded by Commissioner Beasley-Pittman.
