TITLE: Resolution Ratifying a Cemetery Fee Waiver and Refund of \$9,506.84 for

the Burial of Chaplain Father Ronald G. Perkins – (Commission Districts

1, 2, 3 and 4)

Recommendation

Staff recommends that the City Commission adopt a resolution ratifying the waiver of cemetery interment fees and refund the previously paid amount of \$9,506.84, for the burial of Chaplain Father Ronald G. Perkins.

Background

On Sunday, June 22, 2025, Chaplain Father Ronald G. Perkins passed away while traveling with his family. Memorial services were held on Thursday, July 10 and Friday, July 11, 2025, at the Sanctuary Church in the City of Fort Lauderdale. Chaplain Perkins was buried on Friday, July 11, 2025, at Lauderdale Memorial Park, in the City of Fort Lauderdale.

Affectionately known as "Father Ron," he was a cherished spiritual leader and source of unwavering support to the South Florida public safety community. Chaplain Perkins served the Fort Lauderdale Police Department since 2009, the Fort Lauderdale Fire Rescue Department since 2012, and other municipalities and agencies throughout Broward County. Chaplain Perkins was a dedicated public servant who prioritized the mental and spiritual wellbeing of our public safety personnel during difficult times and challenging situations.

Chaplain Perkins was a resident of the City of Fort Lauderdale and a veteran of the U.S. Navy. As such, the internment fees of \$9,506.84 reflect a City of Fort Lauderdale resident discount and burial in the Veteran's Garden section of Lauderdale Memorial Park.

On July 3, 2025, cemetery interment fees in the amount of \$9,506.84 were fully paid by the Perkins family. However, in recognition of Chaplain Perkins's dedicated service and significant contributions to City of Fort Lauderdale and other local first responders, City staff, at the direction of the City Manager, waived the cemetery interment fees and provided a refund of the fees paid. It is recommended that the City Commission ratify the

cemetery fee waiver and the associated refund.
