## Recommendation

It is recommended that the City Commission approve Work Order No. 7 in the amount of \$63,633.00 under the Annual Utilities Restoration Contract with Molloy Bros. Inc., Project 11857.

## Background

In compliance with Section 2-179(5) of the City Code of Ordinances, all work orders under any annual contract in a cumulative amount over \$25,000.00 must be brought back to the City Commission for approval.

The Annual Utilities Restoration Contract provides the City with the ability to complete utility system repairs that are beyond the capability or capacity of City crews and equipment. The contract was renewed by the City Commission on August 20<sup>th</sup>, 2013, in the not to exceed amount of \$749,830.00. Work orders are assigned only on an asneeded, per available funds, basis. Note, the contract sum is not a guarantee of the amount of work that will be issued.

Work Order No. 7: encompasses two (2) locations: 1) (1200 East Las Olas Boulevard) repair of a 10-inch water main in the sidewalk area, estimated cost \$51,050.00, and 2) (3150 Northwest 69<sup>th</sup> Court) repair of a broken section of 8-inch clay pipe sewer main, estimated cost \$12,583.00.

Please note, work includes excavation, backfilling, roadway restoration (including full lane asphalt milling and resurfacing), and site restoration of curbs, gutter, paver sidewalk, retaining wall, and sod.

## **Resource Impact**

There is a fiscal impact to the City in the amount of \$63,633.00 for Work Order No. 7,

and \$10,817.61 for associated engineering fees, for a total cost of \$74,450.61.
