TITLE: Motion Approving a Construction Agreement for NE 4th Avenue

Streetscape Improvements - FG Construction, LLC - \$864,106-

(Commission District 2)

### Recommendation

Staff recommends the City Commission approve a Construction Agreement, in substantially the form attached, for Streetscape Improvements at NE 4th Avenue with FG Construction, LLC in the amount of \$864,106, which includes \$5,000 in allowances for permits, license, and fees.

# **Background**

The NE 4<sup>th</sup> Avenue Streetscape Improvement project is located at NE 4th Avenue, between Sunrise Blvd and NE 13th Street in the City of Fort Lauderdale. The work to be accomplished under this contract includes, but not limited to, widening the sidewalks, implementing street trees, an irrigation system, decorative pavement treatments, a district sign, and infrastructure for future lighting.

On July 11, 2017, the Fort Lauderdale CRA adopted Resolution 17-04 supporting and authorizing the submittal of an application for grant funding through the Broward County Redevelopment Program for the NE 4<sup>th</sup> Avenue Complete Street Project.

On March 5, 2019, the Broward County Commission approved funding for the project in an amount not to exceed \$1,000,000 for engineering design, construction, and inspection.

On February 7, 2023, the Procurement Services Division issued an Invitation to Bid (ITB) No. 12735-1033. The City received the following three (3) bids in response to the solicitation, which was opened on March 16, 2023:

- 1. FG Construction, LLC
- 2. MBR Construction Inc.
- Sagaris Corp.

None of the firms claimed a Disadvantaged Business Enterprise status. All three firms

were reviewed for compliance with the solicitation requirements. FG Construction, LLC met all the solicitation requirements of the ITB and deemed the low responsive, and responsible bidder.

This Agenda Item was originally scheduled for the May 16, 2023, City Commission meeting. However, the City Commission deferred the item to the next City Commission meeting to allow for additional public outreach. Specifically, the Commission requested additional outreach with the Middle River Terrace neighborhood and the South Middle River neighborhood. On May 23<sup>rd</sup> and May 24<sup>th</sup>, City staff presented the item at the South Middle River Civic Association meeting and the Middle River Terrace neighborhood meeting, respectively.

## **Resource Impact**
