WHEREAS, on August 17, 2021, the City Commission adopted Resolution No. 21-148, which approved a request for a one-your extension for Hayes Medical Staffing, LLC to meet its performance requirements for 2020 due to the impacts of COVID-19; and

WHEREAS, on May 17, 2022, the City Commission adopted Resolution 22-104 which consented to a one-year extension for Hayes Medical Staffing, LLC to meet its performance requirements for the Qualified Target Industry business program; and

WHEREAS, Hayes Medical Staffing, LLC has requested another extension to meet its performance requirements.

WHEREAS, Exhibit "A" attached hereto and incorporated herein indicates that the Florida Department of Economic Opportunity has consented to Hayes Medical Staffing, LLC's request for another extension, however, this is the last extension that it is permitted to receive.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:
