

**THIRD RENEWAL OF AGREEMENT

THIS IS A THIRD RENEWAL OF AGREEMENT, made and entered into this 20th day of May, 2014 by and between CITY OF FORT LAUDERDALE, a Florida municipality, ("CITY"), and EE&G ENVIRONMENTAL SERVICES, LLC, a Florida limited liability company, ("CONSULTANT").
