A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, APPROVING AN COLLECTIVE BARGAINING AMENDMENT TO THE AGREEMENT BY APPROVING AND RATIFYING Α MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF FORT LAUDERDALE ("CITY") AND THE FORT LAUDERDALE FRATERNAL ORDER OF POLICE LODGE #31 ("FOP") AMENDING ARTICLE 36 OF THE AGREEMENT BETWEEN THE CITY AND FOP - LIEUTENANTS AND CAPTAINS, AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE MEMORANDUM OF UNDERSTANDING.

WHEREAS, the City of Fort Lauderdale and Fort Lauderdale Police Lodge 31, Fraternal Order of Police – Police Lieutenants and Captains, entered into a collective bargaining agreement for the period of October 1, 2023, through September 30, 2026, ("Collective Bargaining Agreement"); and

WHEREAS, the bargaining agents of the City of Fort Lauderdale and Fort Lauderdale Police Lodge 31, Fraternal Order of Police – Police Lieutenants and Captains, have reached agreement on a Memorandum of Understanding extending the temporary suspension of certain provisions of Article 36 of the Collective Bargaining Agreement related to promotions to the rank of Captain through December 21, 2026; and

WHEREAS, Fort Lauderdale Police Lodge 31, Fraternal Order of Police – Police Lieutenants and Captains, has ratified the Memorandum of Understanding;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. That a Memorandum of Understanding between the City of Fort Lauderdale and the Fort Lauderdale Fraternal Order of Police Lodge #31 Amending Article 36 of the Agreement between the City and FOP - Lieutenants and Captains ("Memorandum of Understanding"), is hereby approved and ratified in substantially the form attached to Commission Agenda Memo #25-0370, and the City Commission authorizes the City Manager to execute the Memorandum of Understanding. **RESOLUTION NO. 25-59**
