TITLE: Motion Rejecting All Bids for Roving Security Guard Services - Invitation to

Bid (ITB) Event No. 97 - (Commission Districts 2 and 4)

Recommendation

Staff recommends the City Commission reject all bids received in response to Invitation to Bid (ITB) Event No. 97 for Roving Security Guard Services.

Background

A new solicitation with a revised scope of services and solicitation requirements will be re-issued to ensure that a bidder will possess the qualification and experience to provide roving guard security services, including at a marina/marine related location. Marinas included in this ITB consist of Cooley's Landing Marina, New River Marina, Esplanade Park floating docks, the Riverwalk and along the Brickel Waterfront (the Wharf).

On May 11, 2023, the Procurement Services Division issued ITB Event No. 97 to establish hourly rates for different levels of Roving Security Guard Services.

On May 26, 2023, the event closed with a total of nine (9) bids submitted.

During the bid analysis and due diligence process to determine responsiveness and responsibility of bidders, it revealed the bid qualification and experience requirements of the ITB did not appropriately reflect the appropriate service needs of the Parks and Recreation Department.

Staff recommends the City Commission reject all bids in response to ITB (Event) No. 97 for Roving Security Guard Services and re-issue a new solicitation with modifications to the scope and requirements.
