TITLE: WALK-ON - Resolution Approving an Airport Infrastructure Grant

Agreement with the Federal Aviation Administration for the Design of Runway 27 Bypass Taxiways and Run-up Area Relocation Project at the Fort Lauderdale Executive Airport - \$637,954 - (Commission District 1)

Recommendation

Staff recommends the City Commission adopt a resolution approving an Airport Infrastructure Grant (AIG) agreement and accepting anticipated grant funding of up to \$637,954 from the Federal Aviation Administration (FAA) for the design phase of the Runway 27 Bypass Taxiways and Run-up Area Relocation Project at Fort Lauderdale Executive Airport (FXE).

Background

The City continues to enhance the safety, efficiency, and operational capacity of FXE's airfield in accordance with its FAA-approved Airport Layout Plan (ALP), last updated in 2019. One of the priority improvements identified in the plan is the Runway 27 Bypass Taxiways and Run-up Area Relocation Project.

The Runway 27 Bypass Taxiways and Run-up Area Relocation Project is designed to address aircraft congestion and ground movement delays that currently occur at the east end of Runway 27. As aircraft queue for departure, delays frequently occur due to limited taxiway access and insufficient run-up capacity.

The construction of the bypass taxiways will be between Taxiway Alpha, one of the primary taxiways serving Runway 27. The reconfigured run-up area will accommodate more aircraft staging prior to takeoff, with appropriate separation to enhance safety and operational efficiency. Overall, the project aims to reduce bottlenecks, enhance airfield safety and support growing aviation demand at FXE.

The design phase will include, but is not limited to, geotechnical and topographical surveys, conceptual planning and construction cost estimates, development of engineering technical specifications, surface water permitting, and updating the Airport's property map per FAA's latest standards.

The FAA has provided an AIG in the amount of \$637,954 to fund approximately ninety-five percent (95%) of the eligible project design costs, with the remaining five percent (5%), approximately \$33,577, to be funded by the City.

At its meeting of August 28, 2025, the Aviation Advisory Board supported staff's recommendation to approve the AIG agreement and accept this grant.

Resource Impact

This action will result in a positive impact to the City in the amount of \$637,954, which will be appropriated to the accounts below, contingent upon the approval of the October 7, 2025, Consolidated Budget Amendment (CAM #25-0723).
