Mayor Trantalis recognized Stephanie Toothaker, Esq., 901 Ponce de Leon Drive, on behalf of Urban Street Development, LLC and Halmos Holdings, Inc. (Applicant).

Ms. Toothaker provided an overview of this Agenda item and narrated a presentation entitled *REVITALIZING HIMMARSHEE INVESTMENT PROPOSAL LONG-TERM GROUND LEASE.*

A copy of the presentation has been made part of the backup to this Agenda item.

In response to Mayor Trantalis' question, Ms. Toothaker confirmed the current lease ends in 2058 and the new fifty (50) year lease begins in 2059 and ends in 2108.

Mayor Trantalis noted property taxes would depend on development of the site. Ms. Toothaker confirmed and clarified that this Agenda item does not relate to future development. It is a response to the RFP for leasing the property and any site plan approval for development would be a separate process.

Vice Mayor Glassman commented that this Agenda item only addresses the lease and recommended the Applicant reach out to the Sailboat Bend Neighborhood and include them in future planning efforts for site development.

Commissioner Herbst remarked that the lease rental rate is substantially below future lease market rates. He discussed conversations with the Applicant regarding a lease rate increase when a Temporary Certificate of Occupancy (TCO) is issued for a future development. In response to Commissioner Herbst's questions, Ms. Toothaker confirmed the Applicant is open to considering a lease rate increase when a development is built. Mayor Trantalis remarked on the vague nature of those discussions. The Applicant said that when a Certificate of Occupancy (CO) is issued for a development, market rate lease costs would start and commented on related information.

In response to Mayor Trantalis' questions, Ms. Toothaker confirmed the

Applicant's response to the RFP included a timeline. She said that the Applicant's intention is to develop the area and lease negotiations with the Office of the City Attorney would include a timeline for development.

Commissioner Sturman recapped details discussed regarding this Agenda item. In response to Commissioner Sturman's questions, City Attorney Thomas Ansbro explained details associated with leasing the property and Charter requirements. The Agenda item includes a separate fifty (50) year lease that begins when the current lease ends in thirty-four (34) years.

Mr. Brown spoke in support of this Agenda and inquired about the number of low-speed vehicles (golf carts) permitted. Mr. Brown commented on the need to not allow golf cart drop-offs and pickups along Seabreeze Boulevard and State Road A1A due to traffic-related concerns.

Mayor Trantalis recognized Milos Majstorovic, Transportation and Mobility Department Acting Director. Mr. Majstorovic explained five (5) current businesses are licensed to rent golf carts and said he would provide the total number of golf cart vehicles.

Vice Mayor Glassman remarked on concerns, including the relationship between the Circuit shuttle service and licensed golf cart rental companies. Vice Mayor Glassman discussed issues related to policies and regulation of golf carts and their signage, and cited examples.

Mr. Majstorovic concurred on the need for golf cart regulation and enforcement. Transportation and Mobility Department Staff will coordinate those efforts with the Office of the City Attorney and the Police Department. In response to Commissioner Glassman's question, Mr. Majstorovic commented on his understanding that there is no limit to the hours of operations for golf carts.

Vice Mayor Glassman remarked on the number of golf cart companies applying for licenses, the anticipation of additional license applications, and the need to be proactive when addressing the concerns regarding this topic.

Acting Assistant City Manager Ben Rogers discussed Staff efforts to modify Ordinances, which will address new modes of transportation such as these. An amendment to the current Ordinance will be presented to the Commission in the Fall. Mr. Rogers said that the speed limit of golf carts is limited and governed by Florida Statute.
