**CITY OF FORT LAUDERDALE PROPOSED HOME-AMERICAN RESCUE PLAN (ARP)**  
**ALLOCATION PLAN AMENDMENT**

The City of Fort Lauderdale is proposing an amendment to its 2022 HOME-ARP Allocation Plan. This amendment constitutes a Substantial Amendment in accordance with the Substantial Change Policy outlined in the City's HUD approved 2021–2022 Annual Action Plan. A substantial amendment is required when a program is added, cancelled, or modified in purpose, scope, location, beneficiaries, or funding.

**Proposed Amendment**

The City plans to update the 2021– 2022 Annual Action Plan and HOME-ARP Allocation Plan to change how it selects developers, service providers, subrecipients, and contractors. The new method will allow both unsolicited proposals and competitive RFPs, aiming to expand opportunities while staying compliant with HOME-ARP standards.

**Public Review and Comment Period**

Citizens are encouraged to review the amended draft of the 2022 HOME-ARP Allocation Plan and submit written comments. The amended draft will be available for a 15day public review and comment period, beginning May 11, 2026, and ending May 25, 2026.

The Housing and Community Development Division will evaluate all comments received during the comment

period and submit a final amendment to the Fort Lauderdale City Commission for its consideration and approval at the public hearing on Thursday, July 2, 2026, at 6:00 p.m., or as soon as possible thereafter at the Broward Center for the Performing Arts, Mary N. Porter Riverview Ballroom, 201 SW 5th Avenue, Fort Lauderdale, Florida 33312. All interested parties may appear at said public hearing and may be heard with respect to the proposed amendment.
