

RESOLUTION NO. 22-

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, ACCEPTING THE BROWARD COUNTY CANVASSING BOARD'S CERTIFICATIONS OF THE NOVEMBER 8, 2022, CITY OF FORT LAUDERDALE SPECIAL MUNICIPAL ELECTIONS, DECLARING THE RESULTS OF SUCH SPECIAL MUNICIPAL ELECTIONS, AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Section 7.12 of the Charter of the City of Fort Lauderdale, Florida, provides, in part, "The city commission shall make all necessary arrangements for holding all city elections, and shall declare the result thereof"; and
