Second Amendment to the Granicus Master Service Agreement between Granicus, LLC and Fort Lauderdale, FL

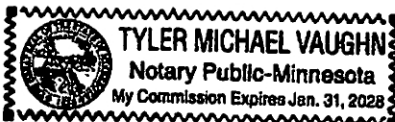
