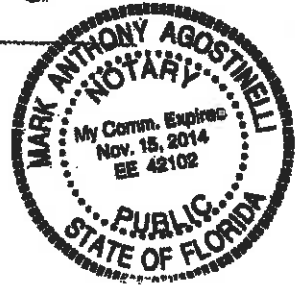

9. Upon receipt of the completed "Appeals Hearing Request Form," collection of your citation will not be processed until notice is received on the outcome of your appeal from the Broward County Clerk of Court.
10. The office of the Clerk of Circuit Court will notify you of the date and time of your hearing.
