TITLE: Grant Acceptance and Supplemental Joint Participation Agreement with the

Florida Department of Transportation for Beach Sun Trolley Routes.

Recommendation

It is recommended that the City Commission adopt a resolution authorizing the City Manager to accept and execute the supplemental Joint Participation Agreement with the Florida Department of Transportation (FDOT) in the amount of \$165,560 for operating funds.

Background

At the November 19, 2013 meeting, the Commission approved Transportation and Mobility Department's request to accept the agreement and funding of the first year of the Service Development grant for operating costs for the expansion of the Beach Link of the SunTrolley service (CAM 13-1007).

FDOT is extending the funding for an additional year of Service Development operating costs of \$165,560 for the 2nd bus for the Sun Trolley Beach Link. No additional City cash match is required; match funds of \$165,560 will be provided by the Downtown Fort Lauderdale Transportation Management Association's (TMA) current non-grant funding sources including the Beach Community Redevelopment Authority, Broward County Transit, gas tax revenues, and private contributions under the terms of the Fourth Amendment to the Agreement between the City and the TMA. The City will draw down grant funds after reimbursing the TMA, the route's non-profit operator, for their grant-eligible expenses. The grant will fund eligible expenses as outlined in the existing agreement with the TMA.

The City and the TMA have a current agreement for community bus operations, approved by the City Commission on October 1, 2013 (CAM 13-1208 M-12). Grant match will be funded by the TMA as approved by the TMA Board of Directors November 19, 2014.

Resource Impact

There is no net fiscal impact to the City. The funding is contingent on the approval of the Consolidated Budget Amendment CAM 14-1219.
