- TITLE: Community Redevelopment Agency Report on the Northwest-Progresso-Flagler Heights (NPF) Community Redevelopment Area Projects, Community Benefit, and Local Contracting Requirements – (Commission Districts 2 and 3)

To follow-up on the Community Redevelopment Agency (CRA) Board's request for information on how CRA's projects are monitored for community benefit and local contracting, a summary of the CRA projects funded under the CRA's Development Incentive Program (DIP) is attached as Exhibit 1.

Reporting requirements specific to each development project is summarized as outlined in their funding agreements. Community benefits include job creation, workforce training, educational opportunities, affordable housing, business expansion, retention and attraction, affordable rents for small businesses and new business development, removal of blight, preservation of the community's heritage and cultural fabric, and promotion of cultural tourism in the area. In addition, most projects require a local preference and best efforts for the hiring of local business firms, minority owned firms, women owned firms and labor surplus firms for CRA funded work.
