TITLE: Motion to approve second extension to agreements for professional traffic

and transportation engineering consultant services - Contract 616-10631-

Consultants Competitive Negotiations Act (CCNA) - \$233,858.

Recommendation

It is recommended that the City Commission approve one-year renewals of the agreements for professional traffic and transportation engineering consultant services in substantially the forms attached with 1) Kimley-Horn and Associates, Inc. 2) Kittelson & Associates, Inc. 3) Miller, Legg & Associates, Inc. and 4) T.Y. Lin International; and authorize the execution of the extensions. It is also recommended that the City Commission approve the amount of \$233,858 for these renewals to be divided evenly (\$58,464.50) among the four consultants.

Background

The initial two-year agreements with Kimley-Horn and Associates, Inc. and Kittelson & Associates, Inc. were approved by the Commission on July 6, 2011, CAR 11-0970. The initial two-year agreements with Miller, Legg & Associates, Inc. and T.Y. Lin International were approved by the Commission on August 23, 2011, CAR 11-1130, CAR 11-1131. The first amendment to the four agreements was approved by the Commission on August 21, 2012, CAM 12-1213; this amendment revised contract language. The first extension to these agreements was approved by the Commission on May 7, 2013, CAM 13-0428.

Resource Impact

There is an estimated resource impact to the City in the amount of \$233,858. Funding for these services will be from individual projects when services are contracted through individual task orders subject to the availability of funds. Future task orders will be issued contingent upon adopted Community Investment Plan projects and operating budgets.
