# First Amendment Agreement Between the Florida Department of Transportation and the City of Fort Lauderdale for the Operations and Maintenance of an Intelligent Transportation System

THIS FIRST AMENDMENT to the Agreement for the Operations and Maintenance of an Intelligent Transportation System ("First Amendment") is made and entered into on this day of January \_\_\_\_\_\_, 2024 by and between the City of Fort Lauderdale ("CITY") located in Broward County Florida, and the Florida Department of Transportation ("FDOT" or "Department"), (collectively, "parties").

WHEREAS, on August 23, 2022, the parties entered into the Agreement for the Operations and Maintenance of an Intelligent Transportation System (hereinafter "Agreement").

WHEREAS, pursuant to the Agreement, ITS Devices were deployed by the CITY at certain intersections, in the City of Fort Lauderdale; and

WHEREAS, Article V, subsection, Amendments, of the Agreement, provides that, "[t]his Agreement may be amended in writing and executed by the parties with the same formality and of equal dignity herewith."; and

WHEREAS, Article III – Functions, Section A. 2. Adding Corridors and/or Intersections, provides that "additional corridors and/or intersections may be added to the Agreement..."; and

WHEREAS, the parties wish to enter into this First Amendment to add additional ITS devices at various locations in the City of Fort Lauderdale.

NOW THEREFORE, in consideration of the premises and the mutual covenants contained herein the parties hereby agree as follows:

- 1. The truth and accuracy of each recital is hereby acknowledged and is hereby incorporated herein, as if set forth in its entirety.
- The Agreement is hereby amended with the attached Exhibit "B" and incorporated herein, which adds additional ITS Devices at specified locations in the City of Fort Lauderdale.
- 3. The parties agree that the City of Fort Lauderdale will pay for the cellular service costs for these additional ITS Devices at the locations in Exhibit B from December 15, 2023, until December 14, 2027. Commencing December 15, 2027, FDOT agrees to pay the cellular service costs for the additional ITS Devices depicted in Exhibit "B" throughout the term of the Agreement.
- 4. Except as modified by this Amendment, all other terms and conditions of the Agreement shall remain in full force and effect.

5. Except as modified herein, all provisions of the Agreement, which are not in conflict with the terms of this First Amendment, shall remain in full force and effect. [REMAINDER OF PAGE INTENTIONALLY LEFT BLANK]
