<u>SECTION 6</u>. That the City Clerk shall cause this Resolution to be published in full in the official newspaper of the City of Fort Lauderdale for two (2) issues, with the first publication at least ten (10) days before the date of such Public Hearing scheduled for <u>August 15, 2023</u>, <u>October 3, 2023</u>, and second publication five (5) days after the first publication.
