

Recommendation

Staff recommends the City Commission consider a motion approving and authorizing the execution of a partial release of a Declaration of Unity of Title.

Background

The Preste Corporation, a Florida corporation executed a Unity of Title recorded on April 22, 1994 in Official Records 22041, Page 129, of the Public Records of Broward County, Florida, for the purpose of considering the property as one plot and parcel of land. The property, 2985 N. Ocean Boulevard, is the site of a Publix Supermarket approved on November 17, 2020 (PLN-SITE-1911004). As a condition of site plan approval, the developer is required to provide the State of Florida Department of Transportation (FDOT) fee simple title to a portion of the property for right of way purposes. In order for FDOT to get "clear title" to the land encumbered by the Unity of Title, FDOT is requiring that the City execute and deliver to FDOT a partial release of Declaration of Unity of Title.

Resource Impact

There is no fiscal impact to the City associated with this action.


