The resolution was revised to reflect a waiver of limitations of Unified Land Development Regulations Section 47-19.3.D, pursuant to Section 47-19.3.E.

All individuals wishing to speak on this matter were sworn in.

Members of the Commission announced with whom they had spoken and/or site visits made concerning this matter.

Mayor Seiler reviewed the procedure for the public hearing and opened the floor for public comment.

Tyler Chappell of The Chappell Group, representing the Applicant, explained that this item was deferred at a previous meeting to allow the Applicant to go back before the Marine Advisory Board to

address concerns about parking on 20 Avenue. The Applicant has agreed that parking will not overflow onto the street. Additionally, a 166-foot mooring pile extension unanimously approved by the Marine Advisory Board has now been reduced to 125 feet. The revised item went back before the Marine Advisory Board and was again unanimously approved.

Charles King, 105 North Victoria Park Road, believed there was one abstention when the Board voted on this matter. The law says that pilings can extend 25 feet or 30 percent of the canal, whichever is less. There has been a history of escalating this street into a shipyard. He chronicled several variances awarded by the Commission in this area. The home in question has no landscaping or grass. He believed it is going to be operated as a small marina. It is tailored for a person with two large yachts who will run the operation from the home with a crew. By law, this is supposed to be a residential home. He read from Marine Advisory Board minutes dated December 5, 2013, listed as Exhibit 4 in Commission Agenda Memorandum 14-0208.

There being no other individuals wishing to speak on this matter, a motion was made by Commissioner Trantalis and seconded by Vice-Mayor Roberts to close the public hearing. Roll call showed: AYES: Commissioner DuBose, Commissioner Rogers, Vice-Mayor Roberts, Commissioner Trantalis and Mayor Seiler. NAYS: None.

Commissioner Trantalis noted he shares some of King's concerns because they have also been expressed by other residents in the area. While the Marine Advisory Board has recommended that only the captain and crew will occupy the house, that could amount to dozens of people. He did not want it to become a party house. Chappell noted that the owner has agreed to include language in the lease that a crew will not occupy the house. There are six parking spaces. The intent is to have a lease holder who will manage the home and the boats. The captains will live there to watch over the boats. There will be two boats and two captains. There could also be some crew members. The owner intends to remodel the home. There will not by any repair work onsite. In further response to Commissioner Trantalis, Chappell advised that the Applicant is agreeable to having the number of tenants limited to the number of vehicles (parking spaces).

Mayor Seiler asked about the City's right to enforce and inspect. Chappell explained that state law requires that the tenant must own vessels docked at the property which is outlined in the permit. The City Manager said the Applicant should provide documentation granting the City right of entry at reasonable times to inspect the home, determine the number of tenants and access the property and vessel. A discussion ensued on this point wherein a potential contradiction in the February 6, 2014 and December 5, 2013 Marine Advisory Board minutes was discovered.

Marine Facilities Manager Andrew Cuba explained the February 6 minutes are in draft form and have not been approved by the Board. Mayor Seiler did not feel comfortable proceeding with approval before confirming the outcome of the Board's discussion. Vice-Mayor Roberts noted a concern because this is a small home in disrepair. There is a question of how it fits into the neighborhood and the adjacent commercial corridor. There is no guarantee that this will not become a marina operation.

Mayor Seiler pointed out that the minutes indicate it was confirmed that the homeowner will reside in the house and operate both vessels, yet tonight it is being indicated this is not correct. He thought it is possible that residents may have also misunderstood the Board's discussion and opted not to oppose the item because of how it is reflected in the draft minutes. He has received emails concerned about traffic and parking. He is comfortable with the reduced distance, but believes the Commission needs clarification on whether the property will be operated as a marina and who will be residing there.

Chappell noted that the Applicant has agreed not to service any vessels onsite, with the exception of washing and waxing. There are 10 letters of support from all neighbors on the same side of the street, including the adjacent property owners. The Applicant is not planning a marina operation. The house will be remodeled. Sales on this street have added value to the neighborhood. With the value level, he did not think property owners would let their homes deteriorate.

Cuba believed the February 6 minutes are complementary to the previous meeting when there was a unanimous vote. Commissioner Trantalis felt there would be a level of comfort if the two sets of minutes were consistent. The City Manager suggested deferral until a recording of discussion could be checked. Cuba confirmed for Mayor Seiler that no one signed up to speak at the Board meeting. Chappell noted the reason this item was heard again by the Board dealt with distance of the mooring piles and parking, not the number of tenants.

Commissioner Rogers agreed the minutes should be accurate, however, he was willing to accept Chappell's sworn testimony. Mayor Seiler wanted to hear from someone on the Board as to whether it was confirmed that the owner would occupy and operate the two vessels. Both sets of minutes indicate they are draft. He would be comfortable with Cuba verifying by listening to the recording. The City Manager offered to provide a verbatim transcript of the point in question. Cuba advised that the December minutes have not been approved and were not amended.
