The purpose of this Change Order ("CO") is:

Since this Project was an emergency procurement with the primary goal of constructing a redundant force main, complete details of this Project were not fully vetted. It is very likely that the additional scope requested in this Change Order would have been considered if enough time was given to develop a detailed design criteria package for this design-build project.

This Change Order is made up of two (2) Request for Proposal ("RFP") from the Contractor:

- 1. RFP 003A Concrete Vault and Conduit Installation This work was required to accommodate the installation of a new 36-inch magnetic flow meter, and a sump pump.
- 2. RFP 003B Line Stop Installation and HDPE Bypass Adjustment This work was required for the construction of the new concrete vault.

The above Requests for Proposals are attached as Exhibit A. These proposals were accepted by the City and all work delineated in the two (2) RFP's was performed in Spring 2021.

Acknowledgements:

- 1. The aforementioned change, and work affected thereby, is subject to all provisions of the original contract not specifically changed by this Change Order;
- 2. It is expressly understood and agreed that the approval of the Change Order shall have no effect on the original contract other than matters expressly provided herein;
- 3. The prices quoted were fair and reasonable and in proper ratio to the cost of the original work contracted for under competitive bidding;


