Brief Project Summary:

Phase I Design and Permitting is underway now. If awarded, these grant funds will be used to support construction costs associated with the installation of an additional concrete floating dock at Esplanade Park/Maritime Museum Floating Dock.

Staff intends to use this grant and a Florida Inland Navigation District Grant as matches for each other to fund the project. However, this grant requires a City match be committed to at the time of application. The FIND grant application Cycle opens in January 2020. Staff intends on applying to FIND for the project match at that time. If both awarded, project funding will be available in October and December of 2121. The estimated cost of the project is \$280,000 plus in house Project management fees of \$56,000 (20%) making the completed project costs of \$336,000. Funding Break down: \$140,000 BBIP, \$196,000 General fund grant match account (331).

Grants Administration Comments:

- The Florida Inland Navigation District (FIND) paid for the design and permitting of the docks through a Phase I grant. **Reimbursement of the Phase I grant is contingent upon beginning construction on the project.**
- The Department intends to submit a request to FIND for Phase II funding which will cover 50% of the construction costs (Approximately \$140,000).
- Due to the timing of the BBIP grant application cycle, the Department will need to show that funding is in place for the grant match which is why funding from the grant match account is being requested, but if the FIND grant is received those funds will be used as a match instead of the General Fund Grant Match.
- Neither the FIND grant nor the BBIP grant covers internal project management costs so those expenses will need to be paid by an internal funding source (i.e. the General Fund Grant Match account).
- **A Commission Resolution is a required part of the application submission.** If approved, the department will submit a CAM.



