A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, APPROVING A CITY OF FORT LAUDERDALE FY 2025 NOT FOR PROFIT SERVICE AGREEMENT WITH TASKFORCE FORE ENDING HOMELESSNESS, INC., AUTHORIZING EXECUTION OF THE NOT FOR PROFIT SERVICE AGREEMENT, AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

WHEREAS, the mission of Taskforce Fore Ending Homelessness, Inc., ("Taskforce") is "[t]o get our neighbors experiencing homelessness off the street through aggressive outreach and services and provide placement in a program that will help them get 'home' in Broward County"; and

WHEREAS, the Taskforce's guiding principle is "[m]eeting people where they are, geographically, emotionally, and philosophically; and guiding them with compassion, fairness and purpose"; and

WHEREAS, the City is providing funds to Taskforce to continue the Housing Navigation Program, to help homeless people within the corporate limits of the City of Fort Lauderdale, which will enhance the public health, safety, and welfare, and thereby serve a legitimate public and municipal purpose;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. That the City Commission approves a City of Fort Lauderdale FY 2025 Not for Profit Service Agreement with Taskforce Fore Ending Homelessness, Inc., ("Not for Profit Service Agreement"), in substantially the form attached to City Commission Agenda Memorandum 24-0998, and authorizes execution of the Not for Profit Service Agreement.

<u>SECTION 2</u>. That if any clause, section, or other part of this Resolution shall be held invalid or unconstitutional by any court of competent jurisdiction, the remainder of this Resolution shall not be affected thereby, but shall remain in full force and effect.

SECTION 3. That this Resolution shall be in full force and effect upon its adoption.
