Staff recommends the City Commission approve the proposed ordinance repealing Chapter 2 "Administration", Section 2-41 "Residence Requirement for Department Directors" of the Code of Ordinances (Code) of the City of Fort Lauderdale (City), Florida. Repealing this section of the Code removes the requirement that department directors reside within the City of Fort Lauderdale during their tenure with the City and allow for better recruitment and retention of qualified applicants.
