Under the rule (11B.35.009) of the Florida Criminal Justice Standards and Training Commission, you must have been a full time sworn officer for one full year or more and have received training in each of the subjects above, applicable to your field, in another state or with a federal agency. If any subjects listed above were not included in your original basic training program, you will have to take those additional courses at a Florida certified training center, to be eligible to take the Pre-Exam qualification course and take the State exam.

Upon receipt of the documents, we will contact your employers and training schools to verify the information you provided. When we have completed verification of your training and employment, we will submit your approval to the (FDLE) Florida Department of Law Enforcement and forward the original documents to you.

All information pertaining to your law enforcement certification must be confirmed by our office, 3 weeks prior to the start of our Pre Exam Qualifications course. If this is not complete, you will <u>not</u> be able to attend the upcoming E.Q. course.
