## ORDINANCE NO. C-24-

AN ORDINANCE OF THE CITY OF FORT LAUDERDALE. AMENDING THE NON-BARGAINING-UNIT CLASSIFICATION TABLE OF THE PAY PLAN OF THE CITY OF FORT LAUDERDALE, FLORIDA, AS AMENDED, BY CHANGING THE PAY GRADES OF THREE CLASSIFICATIONS AND CREATING AND ADDING TWO JOB CLASSIFICATIONS, AMENDING SCHEDULE VI OF THE PAY PLAN OF THE CITY OF FORT LAUDERDALE, FLORIDA, BY **MODIFYING PAY FOR** THE **GRADE TWO** CLASSIFICATIONS, AND PROVIDING FOR SEVERABILITY, REPEAL OF CONFLICTING ORDINANCE PROVISIONS, AND AN EFFECTIVE DATE.

WHEREAS, the City Manager and the Director - Human Resources recommend amending the Non-Bargaining-Unit Classification Table of the Pay Plan of the City of Fort Lauderdale, Florida, as amended, by changing the pay grades of three job classifications and adding two new job classification, and amending Schedule VI of the Pay Plan of the City of Fort Lauderdale, Florida, by modifying the pay grade for two classifications;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:
