EXTENSION OF AND FIRST AMENDMENT TO AGREEMENT TO SUPPLY CEMETERY MANAGEMENT SERVICES

THIS EXTENSION OF AND	FIRST AMENDMENT TO AGREEMENT TO
SUPPLY CEMETERY MANAGEMI	ENT SERVICES is made and entered into this
day of	, 2012, by and between:

CITY OF FORT LAUDERDALE, a municipal corporation of the State of Florida, hereinafter referred to as "City",

and

CFS FUNERAL SERVICES, INC., a Foreign Profit Corporation operating under the laws of the State of Florida, hereinafter referred to as "CFS".

RECITALS

WHEREAS, pursuant to Motion at its February 5, 2008 City Commission meeting, the City and CFS entered into that certain Agreement to supply Cemetery Management Services during the period October 1, 2008 through September 30, 2013 hereinafter referred to as "Agreement"; and

WHEREAS, pursuant to Part III — Special Conditions, Paragraph 09 of the Request for Proposals attached to and incorporated into the Agreement, the City and CFS wish to extend the term of the Agreement for five (5) years ending September 30, 2018; and

WHEREAS, pursuant to Motion at its October 2, 2012 City Commission meeting, the City approved this Extension of and First Amendment to Agreement to Supply Cemetery Management Services to reflect certain modifications herein provided; and

NOW, THEREFORE, in consideration of the mutual promises contained herein and other good and valuable consideration, the receipt of which is hereby acknowledged, the parties mutually agree as follows:

- 1. <u>Recitals; Capitalized Terms</u>. The above-referenced recitals are incorporated herein as though fully set forth and restated and are made hereof. Capitalized terms used but not defined in this First Amendment which are defined in the Agreement shall have the meanings given such terms in the Agreement.
- 2. <u>Extension of Term.</u> Pursuant to Part III Special Conditions, Paragraph 09 of the Request for Proposals attached to and incorporated into the Agreement, the term of the Agreement is hereby extended to September 30, 2018.

- 3. Compensation and Capital Improvement Plans. The City and CFS hereby agree to the Compensation and Capital Improvement Plan attached as Exhibit "A" hereto for the five (5) year period ending September 30, 2018 and the Amended Capital Improvement Plan attached as Exhibit "B" hereto for the five-year period ending September 30, 2013. CFS shall carry out such capital improvement plan as described in Exhibit "A" and, to the extent not inconsistent therewith, in accordance with the standards applicable to previous capital improvement plans for the Cemetery System under the Agreement.
- 4. <u>Effective Date</u>. The effective date of this First Amendment shall be the date this First Amendment is executed by both parties.

5. Miscellaneous provisions.

- (a) This First Amendment may be executed in one or more counterparts, each of which shall constitute an original and all of which shall constitute one and the same document.
- (b) As amended hereby, the Agreement, as modified herein, shall remain in full force and effect. In the event of any conflict between the provisions of this First Amendment and the provisions of the Agreement, the provisions of this First Amendment shall prevail.
