TITLE: Motion Declaring The Great American Beach Party for Saturday, May 25, 2019 as a Public Purpose Special Event and Creating a Temporary Exemption Relating to the Sale, Possession and Consumption of Alcohol at the Event – **(Commission District 2)**

Recommendation

It is recommended that the City Commission approve a motion declaring The Great American Beach Party, a city sponsored event, scheduled for Saturday, May 25, 2019 from 10:00am – 8:00pm, a public purpose special event, providing for a specific limited temporary exemption from Section 8-85 of the Code of Ordinances of the City of Fort Lauderdale, as it relates to the sale, possession, and consumption of alcohol between the following boundaries: A1A between the southern boundary of SE 5th Street, the northern boundary of Sebastian Street, and the western boundary from the Intracoastal Waterway to the eastern boundary of the Atlantic Ocean.

Background

On May 1, 2012, the City Commission adopted Ordinance C-12-12, allowing the City Commission, by motion, to provide for a limited temporary exemption from Section 8-85 of the Code of Ordinances of the City Fort Lauderdale as it relates to the sale, possession, and consumption of alcohol.

The event will take place from 10:00am - 8:00pm and features live bands, family activities, beach games and contests.

The Great American Beach Party is expected to generate tremendous awareness and exposure for the City of Fort Lauderdale prior to, during, and following the event through extensive marketing, media, and public relations initiatives. It will act as a tremendous marketing tool for the City, which will strengthen Fort Lauderdale's position as a premier destination for tourism, recreation and entertainment.

To ensure the Great American Beach Party can create a one-of-a-kind experience, attract an outstanding crowd, and allow the City to capitalize on the full economic development potential of this public purpose special event, staff recommends a temporary exemption

from Section 8-85, Fort Lauderdale Code of Ordinances relative to open containers of alcoholic beverages in specified entertainment and recreational areas of the City.

As always, the Parks and Recreation Department Special Events Team and the Fort Lauderdale Police Department will work to host a fun and safe weekend for all neighbors.
