TITLE: Motion Approving Purchase of Special Event Clean Up Services – Emerald

Vents Clen LLC - \$180,070 - (Commission Districts 1, 2, 3 and 4)

Recommendation

Staff recommends the City Commission approve a one-year agreement, in substantially the form attached, for the purchase of special event clean up services, from Emerald – Vents Clen LLC (Emerald) in the estimated initial term annual amount of \$180,070 (\$150,058 in FY22; \$30,012 in FY23) and authorize the City Manager to approve three (3), one-year renewal options, for a potential total contract amount of \$720,280, contingent upon appropriation of funds.

Background

The purpose of the proposed agreement is to provide special event clean-up services, which include day and nighttime personnel, as well as equipment. Services include, but are not limited to, management, supervision, and labor in collecting and disposing of recyclables, garbage, trash and litter from special events coordinated by the City's Parks and Recreation Department.

The Procurement Services Division issued Invitation to Bid No. 12544-513 and received eight (8) bids. The bid submitted by Emerald has met all of the bid requirements and deemed the lowest cost, responsive and responsible bidder. Three (3) of the eight (8) bidders have indicated its status as a Disadvantaged Business Enterprise.

Resource Impact

Funds for the proposed agreement, in the amount of \$150,058, are available in the FY 2022 Budget in the account listed below. Future years' expenditures are contingent upon the approval and appropriation of the annual budgets.
