## Background

- Broward County Land Use Policy 2.35.1 introduced in 2017
   Allows allocation of redevelopment units
- City adopted Unified Flex Policy and Map in 2018
   To date, there are no more Flex Units available for allocation
- City will request first allotment of 500 redevelopment units

## **Application Criteria**

- Available to municipalities that have fewer than 250 flexibility units
- Establish Receiving Area
- Establish an implementation policy
- Demonstrate sufficient capacity for impacts to:
  - Public Facilities and Services
  - School Concurrency
  - Affordable Housing
  - Land Use Compatibility
  - Sea Level Rise (Priority Planning Areas)

## Intent

Development applications that meet specific criteria for:

#### **Transfer of Development Rights**

Currently no development entitlements to transfer such development rights to another property through transfer or sale in order to preserve historic buildings.
Redevelopment units would allow the implementation of this policy.

#### Infill Redevelopment

- Smaller infill projects
- Not to exceed a total of 50 units.
- Do not qualify under BCLU Policy 2.16.4 (Affordable Housing)



- Same as the City's Unified Flex Map
- Includes the City's RACs
  - > With exception Central Beach RAC

Includes the following major transit corridors:

- Federal Highway
- Sunrise Boulevard
- SE 17th Street
- Andrews Avenue
- State Road 84
- Davie Boulevard
- NE 4th Avenue and NE 13th Street
- Commercial Boulevard
- Oakland Park Boulevard
