**TITLE:** Motion Approving an Event Agreement and Related Road Closures with  
Trustbridge Foundation, Inc. for the 2024 Uptown 5K on the Runway -  
**(Commission District 1)**

**Recommendation**

Staff recommends the City Commission approve an event agreement and road closure requests with Trustbridge Foundation, Inc. in substantially the form attached, and authorize execution of the agreements by the City Manager.

**Background**

On June 19, 2024, Trustbridge Foundation, Inc. submitted a special event application for the 2024 Uptown 5K on the Runway to be held at the Fort Lauderdale Executive Airport (FXE). The event is scheduled to take place on Saturday, November 16, 2024, which is more than the 90-day application deadline, therefore the special event application fee is \$200. The event impacts will start on Thursday, November 14, 2024, and last through Saturday, November 16, 2024, which includes the setup period, event period, and breakdown period.

The event organizers attended the July 10, 2024, special events meeting to review the event details with City staff including the Parks & Recreation Department, Transportation and Mobility, Police Department, and Fire Department. The special events meetings focus on the operational logistics, cross departmental coordination, and event organizer requirements.

This event organizer is requesting the following special permissions that require City Commission approval:

- Road Closures:
  - NW 15<sup>th</sup> Avenue and East Perimeter Road

City staff invited the surrounding civic associations to the special events meeting as well as sent a copy of the application and site plan. Upon approval, the City's online events calendar will be updated to reflect this event.

The event agreement defines the responsibilities of the event organizer such as covering the associated event expenses and the required certificates of insurance. The event organizers will also secure all other necessary permits and licenses that are required from other agencies. Authorization for the execution of the event agreement is contingent upon the City Attorney’s Office reviewing and approving as to form all documents prior to their execution by the City Manager or designee.
