TITLE: Resolution approving naming of 3850 Federal Highway Park Property to

Mangurian Park – contingent upon the City's acquisition of the park

property.

Recommendation

It is recommended that the City Commission adopt a resolution approving the naming of 3850 Federal Park Property to Mangurian Park, contingent upon the City's acquisition of the park property. The name Mangurian Park is to honor Harry T. Mangurian, a longtime resident of Coral Ridge neighborhood and owner of Mangurian Furniture retail stores.

Background

In February 2014, the Parks and Recreation Department was contacted by Jeff Lis of Stiles Corporation, with a proposal from Coral Ridge Golf Course, Inc., to name the park "Mangurian Park" in honor of Harry T. Mangurian, a longtime resident of the Coral Ridge neighborhood and owner of the Mangurian Furniture retail stores, three of which were adjacent to the park location (Exhibit 1). The City is in the process of negotiating acquisition of the park property.

In compliance with the Guidelines for Naming Parks, Recreation Areas and Facilities (Exhibit 2), Parks and Recreation staff notified the surrounding homeowners associations of the suggested name (Exhibit 3 and Exhibit 4). In addition, two Public Advisory Notices were placed at the Park property located at 3850 Federal Highway to notice that the proposed naming would be placed on the agenda at the May 28, 3014 Parks, Recreation and Beaches Board Meeting. The item was placed on the May 28, 2014 Parks, Recreation, and Beaches Board Agenda for discussion. After reviewing the item, a motion was made by Richard Zaden, seconded by Angela Ward, to accept the naming of 3850 Federal Highway Park Property to "Mangurian Park".(Exhibit 5).

Parks and Recreation Staff recommend approval of naming of 3850 Federal Highway Park Property to Mangurian Park in honor of Harry T. Mangurian.
