# AMENDMENT TO AGREEMENT FOR MICRO-TRANSIT TRANSPORTATION SERVICES

Amendment to the Agreement for Micro-Transit Transportation Services ("Amended Agreement") is made and entered into the \_\_\_\_\_ day of \_\_\_\_\_, 2023, by and between the City of Fort Lauderdale, a Florida municipality ("City"), whose address is 100 North Andrews Avenue, Fort Lauderdale, Florida 33301-1016, and Circuit Transit Inc., A Florida Corporation ("Contractor"), whose address is 501 E Las Olas Blvd., Suite 300, Fort Lauderdale, Florida 33301 (collectively, "parties").

WHEREAS, the City and the Contractor entered into an Agreement for Micro-Transit Transportation Services ("Agreement") on April 28, 2023, based on the City of Pompano Beach's Agreement ("Pompano Agreement"), dated February 23, 2021; and

WHEREAS, pursuant to the Agreement between the City and the Contractor, the term commenced on April 28, 2023, up to and including December 29, 2023; and

WHEREAS, the term of the Pompano Agreement expires on February 23, 2024, unless the parties mutually agree to renew the Pompano Agreement for two (2) additional one (1) year terms, subject to the approval of the Pompano Beach's City Commission and execution by the parties; and

WHEREAS, the City wishes to continue to use the micro-transit transportation services; and

WHEREAS, the parties wish to continue the Agreement from December 30, 2023, through the contract period in the Pompano Agreement of February 23, 2024, including any approved extensions thereto by the City of Pompano Beach; and

WHEREAS, pursuant to the Pompano Agreement, the City wishes to amend the City of Fort Lauderdale's Current Service Areas, as depicted in Exhibit "C" and the City of Fort Lauderdale's Galt Mile Proposed Service Area, as depicted in Exhibit "D", attached and incorporated in the Agreement.

NOW THEREFORE, the parties hereto, in consideration of the mutual covenants, agreements, terms, and conditions contained herein, do agree as to the following:

- 1. The above recitals and representations are true and correct and are incorporated herein.
- 2. The term of the Agreement is hereby extended from December 30, 2023, to run conterminously with the Pompano Agreement, up through and including February 23, 2024, in addition to two (2) additional one (1) year option renewal terms, unless otherwise terminated earlier pursuant to the Agreement's terms.

3.	The parties agree to amend the City of Fort Lauderdale's Current Service Areas, as
	depicted in Revised Exhibit "C", attached hereto and incorporated herein, and the City
	of Fort Lauderdale's Galt Mile Service Area, as depicted in Revised Exhibit "D",
	attached hereto and incorporated herein.

4. Except as specifically amended herein, all other terms and conditions of the Ag		
	shall remain in full force and effect. This First Amendment shall be deemed part of,	
	but shall take precedence over and supersede any provisions to the contrary contained	
	in the Agreement.

## **REVISED EXHIBIT C**



#### Service area:

Service area depicted in the above figure. Downtown Fort Lauderdale Urban Core, Las Olas, and Dorsey Riverbend. On-demand service that connects Historic Dorsey—Riverbend, portion of the Progresso Village, and Flagler Village to Downtown Fort Lauderdale, the Beach, and Las Olas, including parking lots and garages in the area. It also provides access to cultural and entertainment hubs including the MASS District, the Parker Playhouse, and Broward Center for the Performing Arts.

#### Service vehicles:

The number of vehicles in service shall be a minimum of 8 and maximum of 18. Contractor shall deploy vehicles in staggered manner during the day to appropriately meet demand, wait times, and available budget.

### **Service Hours:**

- Monday to Thursday 8a-10p
- Friday 8a-11p
- Saturday 10a-11p
- Sunday 10a-8p

# **Galt Mile Service Area**



### Service area:

Service area depicted in the above figure. On-demand service that connects the Galt Mile Community to area businesses, shopping, restaurants, and neighboring Lauderdale-by-the Sea including parking lots and garages. Two (2) vehicles in operation.

## **Service vehicles:**

One (1) vehicle shall be always in service during service hours. No more than 2 vehicles shall operate in this service area. Contractor shall deploy vehicles in staggered manner during the day to appropriately meet demand, wait times, and available budget.

**Service Hours:** Seven (7) days a week 9a-9p
